Lien sale fees:

\$35.00 fee applies after 72 hours for vehicles valued \$4,000 and under.

\$50.00 fee applies after 72 hours for vehicles valued over \$4,000.00

Additional \$35.00 fee applies to vehicles valued under \$4,000.00 once the lien papers have been printed.

Additional \$50.00 fee applies to vehicles valued over \$4,000.00 when DMV authorizes the sale.

Property Removal:

Personal property does NOT include any items attached to the vehicle, such as: battery, wheels, speakers, radio, amps, steering wheel, hub caps, engine, parts, etc.
